Explanation of Responses:

1. Represents shares of Class A Common Stock purchased under the issuer's 401(K) payroll deduction plan.
2. Includes 288.2479 shares acquired under issuer's 401(k) plan since the date of the reporting person's last ownership report.
3. The deferred compensation stock units were acquired under the Brady Corporation employee deferred compensation plan. Each deferred compensation unit is the economic equivalent of one share of Class A Common Stock. The deferred compensation units become payable in shares of Brady's Class A Common Stock upon the reporting persons cessation of service as an employee of Brady Corporation.
4. The two reported transactions involved an amendment of an outstanding option, resulting in the deemed cancellation of the "old" option and the grant of a replacement option. The option was originally granted on August 2, 2004 and provides for vesting in three equal annual installments commencing on August 2, 2005.
